**O R D E R
(Redistribution of Unclaimed Settlement Payments)**

THIS MOTION, made by the Plaintiff, for an Order to Redistribute Unclaimed Settlement Payments to Listed Class Members, was rendered on the written record.

ON READING the materials filed, including a letter from Class Counsel dated December 15, 2022.

AND ON BEING ADVISED that the Parties consent to the form and content of this Order:

THIS COURT HEREBY ORDERS AND DECLARES AS FOLLOWS:

1. The Settlement Administrator shall make a second attempt at distributing settlement payments to those Listed Class Members that did not deposit their previously sent e-transfers.

2. This second attempt at distribution shall be accomplished by sending physical cheques mailed by Canada Post to the physical addresses that the Listed Class Members that did not deposit their previously sent e-transfers provided to Class Counsel on its Website as part of their registration process.
3. The amount of such payments shall be reduced from CAD\$94.75 per Listed Class Member to CAD\$90.
4. The Settlement Administrator shall receive an amount of CAD\$4.75 per Listed Class Member that did not deposit their previously sent e-transfers as payment for its fees and disbursements.
5. No further attempts at distribution shall be made to any Listed Class Members.
6. Upon the expiration of six months from the date of issue of the cheques sent to the Listed Class Members that did not deposit their previously sent e-transfers, the Defendants shall receive the return of any remaining Settlement Funds.
7. There will be no costs of this motion.
