# Notice Regarding Stonefire Naan 'Authentic Flatbreads' Class Proceeding

## (Ontario Superior Court of Justice Court File No. CV-19-80725-CP)

On July 8, 2019, Mr. Kazemi (the "**Plaintiff**") commenced a proposed class proceeding against FGF Brands Inc. (the "**Defendant**"). The proposed class proceeding involved all of the Defendant's naan products under the Stonefire brand, the Fabulous Flats brands, and those under a variety of other store brands such as President's Choice, Santosh, Reya, Rivaj, and Tando.

The Defendant denies all of the allegations made against it in the proceeding.

The proceeding was never advanced to certification and, as a result, the Ontario Superior Court of Justice has ordered that, effective June 26, 2023, the proceeding is dismissed for delay pursuant to s. 29.1 of the *Class Proceedings Act, 1992.* 

**TAKE NOTICE THAT** while this proposed class action was pending, limitation periods (time limits) for starting individual claims against the Defendant regarding matters alleged in this class action were suspended. Upon the expiry of a limitation period, you may lose any right you might have had to sue. If you wish to pursue your own action against the Defendant, you should consult with your own lawyer, as you may need to take steps to protect your rights.
