Motions to authorize class actions were filed against Beiersdorf Canada Inc. ("Beiersdorf") alleging that certain representations in the advertising for and packaging of NIVEA MY SILHOUETTE!<sup>TM</sup> and GOOD-BYE CELLULITE products (the "Products") were misleading.

A Settlement has now been approved by the Superior Court of Quebec. The Settlement provides for payment of all valid claims by way of cash or coupon payments that depend on the number of Products purchased in Canada prior to December 20, 2012 and the proof of purchase provided by the Class Member. There is no maximum overall payment to all Class Members together. Each individual Class Member is subject to a maximum recovery of \$100 (cash and coupons). The Superior Court of Quebec, has approved the payment of legal fees and expenses to Class Counsel in the total amount of \$237,500.

To claim payment, you must complete and submit a Claim Form supported by proof of purchase.
